

# Fox Valley AEYC Scholarship Application

## COLLEGE/UNIVERSITY CREDIT COURSE

The purpose of this scholarship is to provide funds to be used for college/university “per tuition hour” fees for credit courses directly related to Early Childhood Education, at the college/university of your choice.

### Criteria for this scholarship:

- ◆ College/University Credit Course Scholarship funds will be distributed only to Fox Valley AEYC members following their first completed membership year. Money may not be used for books.
- ◆ 80% of costs up to \$300.00, whichever is less, will be awarded per course.
- ◆ A maximum of \$600.00 per year can be awarded to any one individual.
- ◆ Proof of cost and payment must be submitted with the scholarship application.
- ◆ Application must be made prior to or during the semester/quarter of the course.
- ◆ Notification of scholarship award will be made during the semester/quarter of the application.
- ◆ The pay out of the scholarship funds will be made following the receipt of official documentation of a course grade of A or B.
- ◆ Recipient is required to send documentation of course grade within 30 days of receipt to the Scholarship Chair.
- ◆ Recipient must receive at least 75% of possible points on the criteria evaluation to be awarded this scholarship.
- ◆ Recipient must live in the Fox Valley AEYC affiliate area - Kane, Kendall or McHenry County.
- ◆ Application must be submitted on a current application.

### Restrictions for this scholarship:

- ◆ Upon receipt of scholarship funds, the recipient agrees to all conditions of this application.

### Decision of this scholarship:

- ◆ Decisions are based on previous scholarships received, the number of requests received and the order in which they are received each fiscal year.
- ◆ Decisions will be at the discretion of the Scholarship Committee.
- ◆ All scholarship funds are subject to availability.
- ◆ Incomplete applications will be returned and reprocessed in the order of which they are received completed.

### Penalties for this scholarship:

- ◆ Failure to complete your stated intention of question #12 will require a monetary payback.
